## Staff Report

### Origin

Pursuant to Section 168 (1) of the Community Charter, at least once a year the total remuneration, benefits and expenses incurred by each member of Council must be reported.

### Analysis

Total remuneration paid to Council members for the year 2007 was \$426,499.38. Total expenses including any benefits were \$49,306.36 for a total of \$475,805.74. The schedule below provides a summary for each Council member.


