### **OPPORTUNITY**

The Richmond Public Art Program and Richmond Art Gallery invite artists and artist collectives/groups to submit lens-based proposals for temporary public art installations at one of two locations on the Canada Line: Aberdeen Station and Brighouse Terminus Station, as part of Capture Photography Festival 2025.

Artist Fee:	\$1,500.00 CAD
Submission Deadline:	August 5, 2024
Eligibility:	Open to Professional Artists*
Exhibition Duration:	April 2025 - March 2026

\*Richmond-based applicants will be prioritized for Brighouse Terminus Station.

## call to artists

There are two (2) station locations available for temporary art installations:

- Aberdeen Canada Line Station, 4100 No.3 Road
- Brighouse Canada Line Terminus Station, 6222 No.3 Road

Applicants are encouraged to visit the current public art installations and locations before applying to this call. Please refer to Figures 2 and 3 for more information on the artwork locations.

#### BUDGET

The artist or collective for each station commission will receive an artist fee of \$1,500.00 CAD to produce print-ready digital artwork file(s) for one station location. Commissioned artists will be required to work with a City contractor to prepare artwork print file(s) to satisfy printing and installation requirements.

Printing and installation costs for digital print reproductions on adhesive vinyl will be provided by the City of Richmond. The City will also manage the installation and maintenance of the work.

### ARTIST ELIGIBILITY

This opportunity is open to professional artists. The location at Brighouse Terminus Station will be dedicated to the presentation of work by a Richmond-based artist or artist collective. City of Richmond employees, Richmond Public Art Advisory Members and artists who are currently contracted by the City of Richmond are not eligible to apply.

### THEMATIC FRAMEWORK

Richmond Public Art and the Richmond Art Gallery seek exhibition-ready work that embodies a wide range of aesthetics, approaches and artistic backgrounds. Inspired by the Canada Line public transit system and the many people it transports daily, this project is intended for lens-based artworks that reflect the storied experiences—whether personal or collective, imagined or real—of those living in Richmond, the Lower Mainland region, and beyond.

Keywords: storytelling, histories, community, movement

The City of Richmond will support two artists or collectives in presenting exhibition-ready lens-based public artworks exploring these themes. They will be presented as part of the Capture Photography Festival on the Canada Line from April 2025 to March 2026.

### SELECTION PROCESS

A three-person selection panel consisting of professional artists, art professionals and community members will engage in a one-stage artist selection process. At the conclusion of the process, the panel will recommend two (2) artists (or artist collective) for the commissions. The selected artists will enter into contracts with the City of Richmond.

### **ARTIST SELECTION CRITERIA**

Submissions will be reviewed and decisions made based on:

- Artistic merit of artist's response to the thematic framework and how the opportunity will inform the artist's practice
- Artwork's capacity to respond to the Public Art Program goals:
  <u>Public Art Policy</u>

### SUBMISSION REQUIREMENTS

- **INFORMATION FORM** Please complete the information form attached to this document
- **STATEMENT OF INTENT** One (1) page, maximum 300 words, including a brief description of your proposed artwork and how it fits within the thematic framework of the call for submissions. Please indicate if you have a preference for one of the two artwork station locations
- **ARTIST CV and BIO** Two (2) page maximum. Artist collectives should include one (1) CV page for each member. Artist bio, maximum 200 words per artist member
- **PROPOSED ARTWORK** Submit up to five (5) low-resolution digital images of proposed artworks. One image per page. Please include artist name, title, year and medium information as captions on each image page. Release Forms must be obtained by the artist from any person(s) depicted or represented in selected artworks for the exhibition.

### SUBMISSION GUIDELINES

- 1. All supporting documents must be complete and strictly adhere to these submission requirements (above) or risk not being considered.
- 2. All proposed artworks must be print-ready.
- 3. If submitting as a team, the team should designate one representative to complete the entry form. Each team member must submit an individual resume/curriculum vitae. (See Submission Requirements)
