BUSINESS RECYCLING RESOURCES PROGRAM

Bylaws, Bans and Your Business



Richmond's Business Recycling Resources Program provides support to help businesses increase recycling and manage their waste.

There are a number of bylaws and disposal bans that affect businesses. The following is a summary of the key regulatory requirements for businesses operating in Richmond. *Please note that the tools and resources in this program should be used with, not in place of, all applicable building codes, City standards and other relevant legislation.*



Metro Vancouver Disposal Bans

Metro Vancouver is the regional government responsible for overall waste management and planning for the 21 member municipalities in the region, as well as one electoral area and one treaty First Nation.

In addition to establishing regulatory requirements and responsibilities for waste management, Metro Vancouver also determines what items are banned from the garbage.

At Metro Vancouver disposal facilities, loads are inspected for items banned from the garbage, such as recyclable materials, product stewardship materials, or hazardous materials that pose a risk to waste collection workers, the public or the environment.

If banned materials are found in the garbage at Metro Vancouver disposal facilities, fines can be applied to the affected loads and these costs can be passed down to individual businesses.

BANNED FROM THE GARBAGE

These materials are not permitted in the garbage in Richmond (as a member municipality of Metro Vancouver). Your business must have a plan to dispose of these items, including using recycling depots or contracting a private waste hauler service for collection.

HAZARDOUS AND OPERATIONAL IMPACT MATERIALS



Some hazardous materials that are banned from the garbage can be recycled through provincially regulated recycling programs, while others are considered hazardous to people, animals and the environment or have high operational impacts and require special handling and/or safe disposal.

These items may be safely disposed of at the Richmond Recycling Depot.

HAZARDOUS AND OPERATIONAL IMPACT MATERIALS Requiring Businesses to Source and Use a Safe Disposal Option

Operational Impact Materials may cause undue risk of injury or occupational disease to people at a disposal site or the public and environment, or may adversely impact operations at a disposal site. See Metro Vancouver's Disposal Ban Program webpage for details.

- Asbestos
- Biomedical waste
- Containers bigger than 205 L
- Creosote-treated wood
- Gypsum / drywall

- Flammable materials
- Mattresses
- Refuse that would cause undue risk of injury or occupational disease to any person at the disposal site or contravene Occupational Health and Safety Regulations
- Toxic plants (Giant hogweed, Daphne/Spurge laurel and Devil's club)

SINGLE-USE PLASTIC BAN BYLAW

City of Richmond

Single-Use Plastic and Other Items Bylaw No. 10000 was adopted to help reduce unnecessary waste and plastic pollution, and affects all businesses operating in Richmond.

The bylaw bans the use of plastic checkout bags, plastic straws and foam food service ware for prepared foods.

Related Federal Legislation

The federal government has enacted Single-Use Plastics Prohibition Regulations which will prohibit the manufacture, import, and sale of six categories of single-use plastics: checkout bags, cutlery, food service ware made from or containing problematic plastics, straws, ring carriers and stir sticks.

Related Provincial Legislation

The provincial government has enacted the Single-Use and Plastic Waste Prevention Regulation which will ban and restrict the sale of the various single-use plastic items in a phased implementation timeline. This regulation works alongside the City's Bylaw 10000, which remains effective and enforceable.

PUBLIC HEALTH PROTECTION BYLAW

The City of Richmond regulates rodent control in order to protect public health.

Please be advised that the Medical Health Officer and an Inspector are authorized to enter any buildings/land for the purpose of determining the presence of rodents and may order any person to take steps to control rodents.

Point of Sale Items (posters, shelf signs, tabletop display, window decals)

Businesses are required to:

- Refrain from storing waste or debris in a manner that could shelter or provide food for rodents
- Construct and maintain buildings to prevent rodent access
- Dispose of food correctly so as to not attract rodents
- Dispose of food contaminated by rodents as it is not fit for • human consumption



UNSIGHTLY PREMISES REGULATION BYLAW

The City regulates the upkeep of properties, as outlined in the *Unsightly Premises Regulation Bylaw No. 7162*. This bylaw states a property owner or occupier must not allow the property to become or remain unsightly, or cause or permit the collection or accumulation of rubbish, filth, discarded materials, noxious or offensive or unwholesome matter or substances on or around the property.

ILLEGAL DUMPING

Property owners must ensure garbage and recycling materials are properly stored and maintained to ensure there is no risk to public health or safety. Garbage and recycling service issues are regulated under Solid Waste & Recycling Regulation Bylaw No. 6803.

This bylaw outlines specific requirements for property owners. In particular:

- No person may place garbage or recycling materials out for collection on another person's property.
- Dumping is illegal A person must not deposit or dump garbage or other discarded materials on any road, park, or public place. This is a ticketable offence.

How to Report Illegal Dumping

- **Private property**: Call Richmond RCMP at 604-278-1212.
