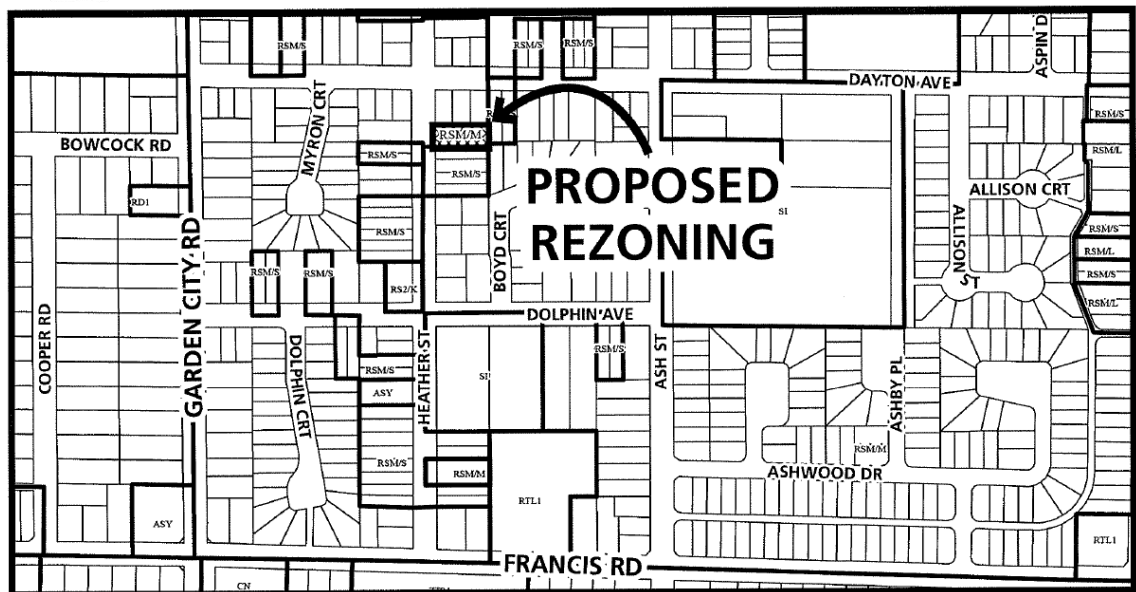
**1. RICHMOND ZONING BYLAW 8500, AMENDMENT BYLAW 10730 (RZ 24-049110)**

**Location/s:** 8560 Heather Street

**Applicant/s:** Haven Craft Homes Ltd.

**Purpose:** To rezone the subject property from the “Small-Scale Multi-Unit Housing (RSM/M)” zone to the “Small-Scale Multi-Unit Housing (RSM/S)” zone to permit the property to be subdivided into new lots, each lot containing a proposed single-family home and a secondary suite, with access from Heather Street.

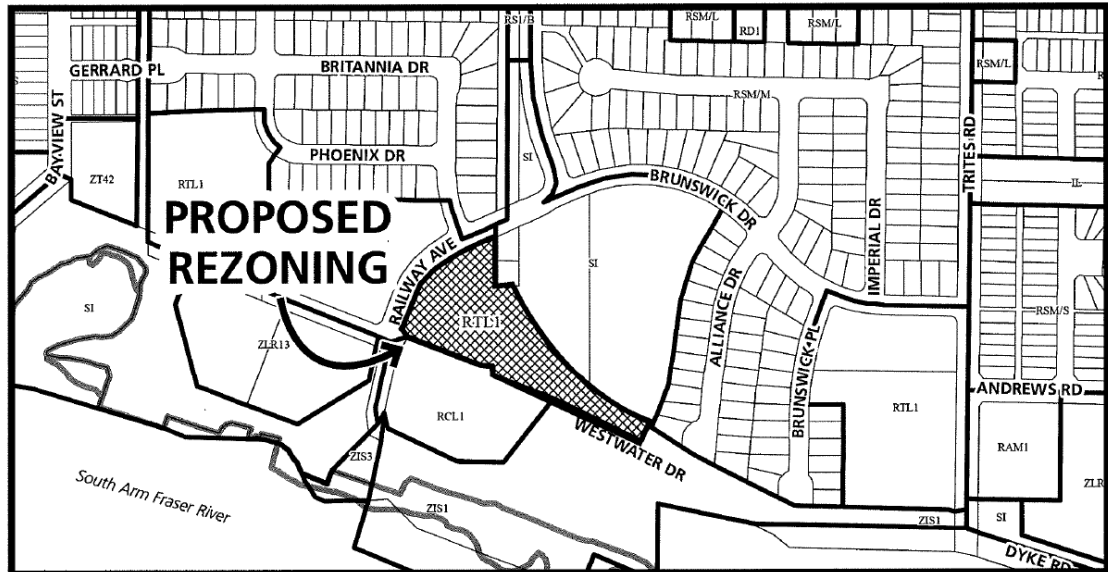
**2. RICHMOND ZONING BYLAW 8500, AMENDMENT BYLAW 10734 (RZ 25-029406)**

**Location/s:** 12871, 12873, 12875 Railway Avenue

**Applicant/s:** City of Richmond

**Purpose:** To rezone the subject property to align the property’s zoning with the existing land use and three and a half storey apartment buildings. No new development is proposed.
