Affordable Housing Guide

The purpose of this guide is to provide information on the different types of affordable housing options in Richmond. Richmond is home to a range of affordable housing options for low and middle income households, including individuals, families, persons with disabilities and seniors.

In Richmond, affordable housing is managed by the different housing providers included in this guide. The City of Richmond does not manage affordable housing units or accept applications for affordable housing. The guide contains contact information for where to apply for the affordable housing options available in the city however, it does not include information on current vacancies.

Please note that due to high demand for affordable housing in Richmond, eligible applicants must often wait for an affordable housing vacancy to become available.

The Affordable Housing Guide is divided into four colour-coded sections based on different types of affordable housing available in Richmond:

- Non-Market housing;
- Housing co-operatives;
- · Low-End Market Rental (LEMR) units; and
- BC Housing rent supplement programs.

Non-Market Housing

Non-market housing is a type of affordable housing offered at low or very low rental rates. Some non-market housing providers provide housing with rental rates based on a household's income, while others offer housing with rental rates lower than what is found in the private rental market.

How to Apply

Housing co-operatives (co-ops) are organizations where residents (called "co-op members") collectively manage their housing. Co-ops are usually mixed income communities and often include both subsidized as well as market rental units. Members are expected to participate in their co-op and participation requirements vary by co-op. Low End Market Rental (LEMR) Units

In large-scale developments, the City commonly requires the inclusion of Low-End Market Rental (LEMR) units. LEMR units are intended to provide affordable housing to those with low to moderate incomes who may not otherwise be able to afford rents at typical market rates. Since 2007, the City has successfully secured hundreds of LEMR units for those in need.

Developments with LEMR units are tied to housing agreements that establish maximum rents and other terms that benefit Richmond residents, such as ensuring equal access to amenities and prohibiting age-based restrictions. Tenant eligibility is most commonly tied to the gross (before-tax) income of the household. Annually, inflationary adjustments are permitted to the rent and income thresholds, as defined in the terms of the housing agreement.

Two distinct frameworks have been used to secure LEMR units. Before 2017, the majority of LEMR units were secured with housing agreements tied to BC Housing's Household Income Limits (HILs). HILs are based on figures established by the Canada Mortgage and Housing Corporation (CMHC) and are intended to reflect the minimum income required to afford appropriate accommodation in the private market; BC Housing publishes its HILs annually.

In 2017, by creating the Affordable Housing Strategy (2017–2027), Council adjusted the LEMR program to ensure rents remain within reach of low-income households. This adjustment resulted in a second income and rent package listed in the City's LEMR Bulletin. The Income Thresholds and Maximum Rental Rates outlined in the Bulletin have been incorporated into affordable housing agreements since 2017 and these rates continue to be used to secure new LEMR units.

To apply for a LEMR unit please contact the property manager using the information outlined under "Who to Contact" in the tables below. The City of Richmond does not directly manage LEMR units but staff are happy to assist members of the public in better understanding the limits that may apply to a specific development.































LEMR Units Secured Before 2017

Most LEMR units built before 2017 define tenant eligibility using BC Housing's HILs. Maximum rents within developments that are tied to HILs are set at 30% of the HIL divided by 12 (months). Those looking to access a HILs-based LEMR unit are encouraged to check the most current HIL to determine their eligibility. In 2023, for example, the HIL for a two-bedroom unit was \$72,000 and maximum rent was set at \$1,800 per month. More information regarding current HIL rates can be found on BC Housing's website (bchousing.org). The City of Richmond uses the "Vancouver" Planning Area HIL rates.

LEMR Units Secured After 2017

LEMR units secured after 2017 set income thresholds at 10% below BC Housing's 2016 HILs and set maximum rents at 10% below CMHC's 2016 market averages. These rates are outlined in the City's LEMR Bulletin (INFO-60). It is important to note that housing agreements allow for an annual inflationary adjustment to both maximum rents and income thresholds. As a result, the maximum rent rates and income limits listed in the City's LEMR Bulletin may be lower than those currently charged to new and existing LEMR unit tenants.

Note 1: The terms of housing agreements for The Nova and The Camber were secured in 2010. The agreements permit annual adjustments to the Income Threshold at a rate of CPI plus 2% and an increase to maximum rent at a rate of CPI plus 2% or the increase permitted under the Residential Tenancy Act, whichever is lower.

Note 2: The Park Residences development is geared to seniors and is tied to a housing agreement secured in 2008. The agreement sets "original rent" at \$1,000 (or less) per month and allows an annual rent increase by any percentage change in the CPI and the maximum permitted under the RTA, whichever is lower.



BC Housing Rent Supplement Programs

BC Housing develops, manages and administers a wide range of affordable housing options across the province. BC Housing also offers rent supplement programs that provide financial assistance towards rent payments for eligible residents.
